BOARD OF MANAGEMENT

- Pursuant to the Enterprise Law, the Insurance Business Law and the implementation guiding documents:
- Pursuant to the Amended License No.28/GPDC2/KDBH dated 18/02/2008 of the Minister of Finance on amendment of License of Establishment and Operation No. 28GP/KDBH dated 15/11/2004 of the Minister of Finance on establishing Vietnam National Reinsurance Company;
- Pursuant to the Charter of Organization and Operation of Vietnam National Reinsurance Corporation;
- Based on voting resultsin writing on appointing personnel to represent the management in other companies.

DECIDES

<u>Article 1:</u>To approve the discharge of the position of Capital Representative and member of the BOM of the following individuals:

- Mr. Trinh Quang Tuyen: ceasing to be Vinare's Capital Representative and BOM Member in the following companies: Petrolimex Insurance Joint-stock Company, Post & Telecommunications Insurance Joint-stock Company, Global Insurance Joint-stock Company.
- Mr. Pham Cong Tu: ceasing to be Vinare's Capital Representative and BOM member in the following companies: Bao Tin Insurance Joint-stock Company, Agriculture Bank Insurance Joint-stock Company.

<u>Article 2:</u> To appoint Vinare's Capital Representatives and nominating them to participate in BOM in other insurance companies:

- Mr. Tran Minh Tuan, Manager of Energy and others Department, Vinare, to represent the capital contribution of VND29,867,910,000 of Vinare in Petrolimex Insurance Jointstock Company (PJICO). Nominating Mr Tran Minh Tuan to stand for BOM member of PJICO.
- Ms. Luu Thi Viet Hoa, Chief Accountant of Vinare, to represent the capital contribution of VND17,600,000,000 of Vinare in Global Insurance Joint-stock Company. Nominating Ms Luu Thi Viet Hoa to stand for BOM member of Global Insurance Joint-stock Company.
- Mr. Nguyen Huu Duc, Director of Vinare Branch in Ho Chi Minh City, to represent the capital contribution of VND8,000,000,000 of Vinare in Bao Tin Insurance Joint-stock

- Company. Nominating Mr Nguyen Huu Duc to stand for BOM member of Bao Tin Insurance Joint-stock Company.
- Mr. Dang The Vinh, CEO Assistant, Vinare, to represent the capital contribution of VND32,000,000,000 of Vinare in Agriculture Bank Insurance Joint-stock Company (ABIC). Nominating Mr Dang The Vinh to stand for BOM member of ABIC.
