**On approval of changes to the share listing registration of
Vietnam National Reinsurance Corporation**

Pursuant to Decision No. 01/QD-HDTV dated 30 June 2021 of the Board of Members of the Vietnam Stock Exchange on the establishment of the Hanoi Stock Exchange;

Pursuant to the Charter on organization and operation of the Hanoi Stock Exchange promulgated together with Decision No. 08/QD-HDTV dated 09 July 2021 of the Board of Members of the Vietnam Stock Exchange;

Pursuant to the Law on Securities No. 54/2019/QH14, as amended and supplemented by Law No. 56/2024/QH15;

Pursuant to Decree No. 155/2020/ND-CP dated 31 December 2020 of the Government detailing the implementation of a number of articles of the Law on Securities, as amended and supplemented by Decree No. 245/2025/ND-CP;

Pursuant to the Regulations on listing and trading of listed securities promulgated together with Decision No. 22/QD-HDTV dated 16 March 2026 of the Board of Members of the Vietnam Stock Exchange;

Having considered the dossier for changes to the listing registration submitted by Vietnam National Reinsurance Corporation;

At the proposal of the Director of the Listing Management Department.

DECIDES:

Article 1. To approve the change to the share listing registration of Vietnam National Reinsurance Corporation with the following details:

- Name of securities: Shares of Vietnam National Reinsurance Corporation;
- Type of shares: Ordinary shares;
- Stock code: VNR;
- Par value: VND 10,000 per share;
- Method of issuance: Issuance of shares to pay dividends for 2025;
- Number of shares subject to the change in listing registration: 10,031,026 shares (Ten million thirty-one thousand and twenty-six shares);
- Value of shares subject to the change in listing registration (at par value): VND 100,310,260,000 (One hundred billion three hundred ten million two hundred sixty thousand Vietnamese dong);
- Total number of listed shares: 210,661,274 shares (Two hundred ten million six hundred sixty-one thousand two hundred seventy-four shares);
- Total value of listed shares (at par value): VND 2,106,612,740,000 (Two trillion one hundred six billion six hundred twelve million seven hundred forty thousand Vietnamese dong).

Article 2. Vietnam National Reinsurance Corporation shall disclose information in accordance with prevailing regulations, register the trading date for the newly listed shares within 5 working days from the date this Decision is issued, and comply with the laws and regulations governing securities trading activities.

Article 3. This Decision takes effect from 04 September 2026. The Director of the Listing Management Department and Vietnam National Reinsurance Corporation shall be responsible for implementing this Decision.
